COUNCIL PROCEEDINGS CITY OF STACYVILLE

Mayor Pro Tem Roger Hemann called the regular October meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, October 11, 2021, with council members Jake Gerbig, Jason Hanson, Roger Hemann, and Roger Brumm present. Absent was Allyn Brumm. The Mayor Pro Tem then welcomed all guests and called for approval of the meeting agenda. Gerbig moved to accept the agenda seconded by Hanson and carried. Gerbig moved and R. Brumm seconded to approve the minutes. All voted aye.

The contractor for the water project will be presenting their invoice next month.

The Street Improvement Project is nearing completion. A Northern Country Coop employee removed the cones that protected the concrete that was poured around the manhole covers. The sub-contractor, Mehmert Tiling, said that they were not asked and would not be responsible of damages because of the lack of cement curing. There will be an insulation board installed above the water service line of Jimmy Grimes.

Mayor Paul Halbach arrived at this time.

Hemann moved and R. Brumm seconded to pay Heartland Asphalt \$429,303.48 for their second pay request for the 2021 Street project. All voted aye.

Hemann moved and Gerbig seconded to set the Public Hearing for the sale of a part of Green Street and a part of Randolph Street City Right of Way for November 8, 2021 to be held at 7:30 PM at the meeting room of the Stacyville Public Library. All voted aye.

Shannon Adams was present to give the council an update on the projects she has been working on. There was a back order on the tables for the Community Center. Some were delivered but the rest will come in the spring. Coming events include Halloween, Vendor booths in the Community Center and Christmas in the City. Adams asked to have available a debit card for ordering on line items. Gerbig moved and Hemann seconded to approve having the bank issue a debit card. All voted aye.

The City has received a few requests to fill their ditch. They need to follow the rules that were established at the September meeting.

The City continues to have high water flow in the sanitary sewer when it rains. The council wishes to use the money from Federal American Rescue Act Grant to help pay for expenses to correct this problem.
