

COUNCIL PROCEEDINGS

CITY OF STACYVILLE

Mayor Paul Halbach called the regular November meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, November 14, 2022, with council members Roger Brumm, Allyn Brumm, Jake Gerbig, Alex Emerson, and Roger Hemann present. The Mayor then welcomed all guests and called for approval of the meeting agenda. A. Brumm moved to accept the agenda seconded by Emerson and carried. R. Brumm moved and Emerson seconded to approve the minutes. All voted aye.

Rustin of SEH will be sending out bid requests for the sewer I & I grouting project this week. The project will be awarded at the December meeting.

Shannon Adams was present to clarify the amounts to charge for the use of the Community Center. After some discussion, A. Brumm moved and Hemann seconded to not change the original fees and charge everybody, including the City, the same amount. Ayes R. Brumm, A. Brumm, Hemann; Nays Gerbig and Emerson. Carried.

The splash pad committee told the council it has received many grants already and are still applying. They have received nearly \$60,000 so far. The city said it will pay for infrastructure costs but no amount was determined. Emerson moved and A. Brumm seconded to locate the splash pad just to the east of the current wading pool. All voted aye.

Emerson moved and Hemann seconded by RESOLUTION 2022-12 TO APPROVE THE 2021-2022 STATE ROAD USE TAX REPORT. All voted aye.

The last lot of the industrial park was sold this summer. The City is making contacts to find a new location for a new area for the park.

Public Works Director Joe Erbe met with the Streit family and after running a camera down the sewer line it was determined that the problem with their sewer line needed to be repaired by the Streit family.

The City got notified by the Iowa DOT that the Lawrence Street Bridge was approved for replacement with state paying for the bridge and the City would pay for engineering design and development, right-of-way and inspection. Hemann moved and A. Brumm seconded to approve that the City make application to Iowa DOT that we are interested to participate in the project to replace the Lawrence Street Bridge. All voted aye.

There had been a question as to the process to change the wages for the council and Mayor. The Clerk reported that the Ordinance needs to be changed before the next election and the wage change would then be effective on the following January 1. No action was taken at this time.
