

COUNCIL PROCEEDINGS

CITY OF STACYVILLE

Mayor Paul Halbach called the regular November meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, November 9, 2020, with council members Allyn Brumm, Jake Gerbig, Jason Hanson, Roger Hemann, and Roger Brumm present. The Mayor then welcomed all guests and called for approval of the meeting agenda. Gerbig moved to accept the agenda seconded by Hanson and carried. R. Brumm moved and Gerbig seconded to approve the minutes. All voted aye.

Gerbig moved and A. Brumm seconded by RESOLUTION 2020-14 TO APPROVE THE 2019/2020 ANNUAL STATE FINANCIAL REPORT. All voted aye. Hemann moved and R. Brumm seconded by RESOLUTION 2020-15 TO APPROVE THE 2019/2020 ANNUAL URBAN RENEWAL PLAN REPORT. All voted aye.

Gerbig moved and A. Brumm seconded to approve a 5 year agreement with NIACOG to maintain the City of Stacyville Code of Ordinances for an annual fee of \$600.00. All voted aye.

The contractor will continue with the water project as long as the weather permits. They will finish in the spring if necessary. Gerbig moved and Hemann seconded to approve pay request number one payable to Popp Excavating for \$237,418.52. All voted aye.

Allyn Brumm moved and Gerbig seconded to approve an Agreement for Professional Service with SEH for an amount not to exceed \$42,150.00 for the purpose to survey, design and do bidding work for Street Improvements for the City of Stacyville. All voted aye.

The culvert replacement on College Street will be done this fall.

Work is progressing on the installation of the generators at the Community Center and Water Plant. Chuck Koenigs is the electrician doing the work.

The council reviewed the list of residents that still needed a sump pump inspection. Joe Erbe reported that the smoke machine was in town to test for resident tile lines that are connected to the City sewer.

LeRoy Steward told the council he wants to use Albion Street to access his property from the north. Discussion was held on who would rock the street and the council felt that since Steward was the only one to use the street, he should be responsible for the cost of rock.
