

COUNCIL PROCEEDINGS

CITY OF STACYVILLE

Mayor Paul Halbach called the regular April meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, April 12, 2021, with council members Jason Hanson, Jake Gerbig, Roger Hemann, and Roger Brumm present. Absent was Allyn Brumm. The Mayor then welcomed all guests and called for approval of the meeting agenda. Hemann moved to accept the agenda with additions seconded by R. Brumm and carried. R. Brumm moved and Gerbig seconded to approve the minutes. All voted aye.

Rustin from SEH told the council he incorporated the changes into the road project that were discussed at the March meeting. The bids for the project will be opened May 5 and the project will be awarded May 10. Start date will be August 1, 2021 with completion to be by June 30, 2022. Rustin also gave the council an engineer cost estimate of the project. Hemann moved and R. Brumm seconded by RESOLUTION 2021-3 ORDERING BIDS, NOTICE TO BIDDERS, FIXING AMOUNT OF BID SECURITY, AND ORDERING CLERK TO PUBLISH NOTICE, AND FIXING A DATE FOR RECEIVING SAME, AND FOR A PUBLIC HEARING ON MAY 10, 2021 ON PLANS, SPECIFICATIONS, FORM OF CONTRACT AND ESTIMATE OF COSTS FOR THE CONSTRUCTION OF THE "2021 STREET IMPROVEMENT PROJECT" FOR THE CITY OF STACYVILLE, IOWA. All voted aye.

Rustin said the contractor will be in town this week to finish the water project. They will start at the north end of town first. Rustin also reviewed with the council the list of residents that have not gotten inspected or fixed their problem with illegal "sewer pump" connections. There are still 9 on the list.

The clerk reviewed with the council on the procedures that need to be followed concerning appointments. Previously the council appointed Jake Gerbig for the position of Zoning Administrator. The Clerk had received a notice that someone said that he was now the City Treasurer. None of this is possible since neither the Clerk or Mayor had been notified that Jake Koenigs has resigned from either position.

Hemann moved and Hanson seconded to appoint Alex Emerson to a five year term to the Board of Adjustments. All voted aye.

No one applied for the Marketing director job. The clerk will run the ad again.

Library Director gave written report to the council stating that numbers have been good. The library will now open up to near normal conditions.

The sewer line in the Industrial Park has been cleaned and flushed. Hemann moved and R. Brumm seconded to send the Visu-Sewer bill to the party responsible. All voted aye.

Jendro notified the City Clerk that the garbage rates will need to be raised because of the action of the Landfill Board. The Landfill will be raising the dumping fees

October 1, 2021. Upon a suggestion, the City will have Phil Brumm clean and rock the waterway north of the School Street culvert.
