## COUNCIL PROCEEDINGS CITY OF STACYVILLE

Mayor Paul Halbach called the regular February meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, February 12, 2024, with council members Alex Emerson, Allyn Brumm, Roger Brumm, Jake Gerbig and Roger Hemann present. The Mayor then welcomed all guests and called for approval of the meeting agenda. Hemann moved to accept the agenda seconded by Gerbig and carried. A. Brumm moved and Emerson seconded to approve the minutes. All voted aye.

Mayor Halbach opened the Public Hearing at 7:31 PM to receive comments on the approval of the City of Stacyville Code of Ordinances 2024. No written or oral comments were received. Hemann moved and Gerbig seconded to close the Public Hearing at 7:32 PM. All voted aye. Hemann moved and R. Brumm seconded by RESOLUTION 2023-4 TO APPROVE THE CITY OF STACYVILLE CODE OF ORDINANCES 2024. All voted aye.

Stacyville Kids Care board reported to the council on their needs. It was agreed that the council will by paying for snow removal, garbage pick and 50% electric bill. The reason was that snow removal is a City job, the trash from the park goes into the Kids Care tub and the City receives rent income from the building.

Gerbig moved and A, Brumm seconded to approve the Urban Revit application from Paul Kirtz. All voted aye.

Gerbig moved and R. Brumm seconded to approve the K&N Mini Mart Liquor License and Off Sale. All voted aye.

Gerbig moved and R. Brumm seconded to set the Public Hearing for the City Budget Levy for April 8 at 7:30 PM in the meeting room of the Stacyville Public Library. All voted aye.

James Player was again at the council meeting for the third time. The Zoning Ordinance has a non-conforming use grandfather clause which makes it legal to do commercial work in the residential zoned lot. Player said that the Ordinance says that in the event that the use of the non-conforming building is discontinued for a period of 2 years that the grandfather clause is not valid. The council informed him again that the building had been continuously used.

The rural fire board wants to pay the volunteer fire fighters for meetings and trainings. The council wondered if paying them negates the "volunteer" part and they were not sure of the ramifications.

Allyn Brumm moved and Gerbig seconded to transfer \$10,000 per year to the Fire Truck Fund. All voted aye.

The City hired a company to clean up the ceiling in the gym. The city will remove the old heating pipes before the contractor starts.
